Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ or Order more particularly one in the nature of Writ of Mandamus, declaring the inaction of Respondents No.4 and 5 in not implementing the Order dated 13.03.2026 passed by Respondent No.2 in Proceedings No.D1/2494/2025 with respect to rectification of change of nature of land admeasuring Ac. 3.14 Gts in Survey No.345/103/2 situated in Girmapur Village, Medchal Mandal Medchal Malkajgiri District, Telangana from Lavuni Patta land to Patta land and to remove the said land from prohibited category as being illegal, arbitrary, unjust, violative of Articles 14 and 300A of the Constitution of India, 1950 and to consequently direct Respondents No.4 and 5 implement the Order dated 13.03.2026 in Proceedings No.D1/2494/2025 passed by Respondent No.2 by changing the classification of land admeasuring Ac. 3.14 Gts in Survey No.345/103/2 situated in Girmapur Village, Medchal Mandal Medchal Malkajgiri District, Telangana from Lavuni Patta land to Patta land, removing the said land from prohibited category and mutating the land in favour of Petitioner.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the Respondents No.4 and 5 to consider and dispose off within two weeks the Written Representations dated 18.03.2026 submitted to Respondent No.4 on 18.03.2026 and 5 on 25.03.2026, pending disposal of WP.No.15614 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of SRI. AMBATI SAI VARUN Advocate for the Petitioner and GP FOR REVENUE for the Respondents, the Court made the following.

ORDER:

There shall be interim direction to respondent No.5 to act upon the letter of respondent No.2 bearing Lr. No.D1/2494/2025 dated 11.10.2025 for changing the nature of land admeasuring Acs.3-14 guntas in Survey No.345/103/2, situated at Girmapur Village, Medchal Mandal, Medchal-Malkajgiri District, from Laoni Patta to Patta and removing the same from the prohibitory list of properties, within a period of six (6) weeks from the date of receipt of a copy of this order.
