ORDER

This court vide orders dated 11.07.2024 in I.A.No.3 of 2024 had suspended the operation of the order and decree dated 09.05.2023 passed in M.V.O.P.No.1367 of 2019 on the file of Chairman, Motor Accidents Claims Tribunal-cum- Chief Judge, City Civil Court, Hyderabad, subject to deposit 50% of the award amount along with costs and interest.

The present application is filed to permit the petitioner/respondent No.1 to withdraw the deposited amount along with costs and interest proportionately as per the order and decree dated 09.05.2023.

For the reasons stated in the accompanying affidavit, the interim order granted on 11.07.2024 is modified permitting the claimants to withdraw 50% of the amount deposited before the learned Trial Court pursuant to the direction issued by this Court on 11.07.2024 in IA.No.3 of 2024 without furnishing any security along with costs and interest.
