Learned counsel for the petitioner submits that the *lis* raised in the present Writ Petition has already been adjudicated by this Court in W.P.Nos.32076 of 2025 and 31555 of 2024 *vide* dated 01.05.2025 and 30.05.2025 respectively and therefore, it is prayed to pass a similar order in the present Writ Petition. The above made submission is not seriously disputed by the learned Government Pleader for the respondents. However, it is submitted that aggrieved by the said orders, the State had preferred W.A.No.1199 of 2025, which is pending adjudication before this Court.

Having regard to the above made submissions, there shall be interim suspension of operation of the impugned proceedings in R.C.No.1617/B2/2024 dated 11.06.2025 issued by respondent No.4 and the respondents are directed to reinstate the petitioner into service forthwith.
