Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Writ, Order or Direction, or any other appropriate Order one in the nature of a WRIT OF MANDAMUS, declaring the action of the Respondents not regularizing the property under GOMS.No.59 inspite of submitting application dated 15.03.2022 with all relevant documents and interfering into the peaceful possession and enjoyment of the Petitioner H. No.9- 11- 121 / A/ 1, 9-11-121/A, 9-11-121 /B and 9-11-121/ B/2 to an extent of 2000 Sq. yards situated opposite to Dowlath Khana (Moti Mahal), Jinsi Bazar, Golconda Fort, Hyderabad, as illegal, arbitrary and violation of principles of natural justice, and consequently direct the Respondents to regularize the Petitioner's property as per GOMs.No.59 and not to interfere into the peaceful possession and enjoyment of the Petitioner over H . No .9-11-121 /A/ 1, 9-11-121/A, 9-11-121/B and 9-11-121/B/2 to an extent of 2000 Sq. yards situated opposite to Dowlath Khana (Moti Mahal), Jinsi Bazar, Golconda Fort, Hyderabad.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the Respondents to regularize the Petitioner's property as per GOMs.No.59 and not to interfere into the peaceful possession and enjoyment of the Petitioner over H.No.9-11-121/A/1, 9-11-121/A, 9-11-121/B and 9-11-121/B/2 to an extent of 2000 Sq. yards situated opposite to Dowlath Khana (Moti Mahal), Jinsi Bazar, Golconda Fort, Hyderabad, pending disposal of WP.No.15872 of 2025, on the file of the High Court.

SARWATH MEHDI KHAN learned counsel representing SRI. M.A.K. MUKHEED Advocate for the Petitioner and Assistant GP FOR REVENUE for the Respondents, the Court made the following.
