WHEREAS the Petitioner above named through his Advocate Sri. M A K MUKHEED presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Writ, Order or Direction, or any other appropriate Order one

in the nature of WRIT OF MANDAMUS, declaring the action of the respondent No.2 to 7 to allotted selection of 30 more outsourcing employees to respondent No.8 after allotting 100 outsourcing employees, knowing well that the respondent No.1 to 7 is not eligible to allot the selection process more than 100 outsourcing employees which is against the Rule 19 Tender Notification, issued by Respondent No.2, and not given opportunity to the petitioner who is eligible to select the outsourcing employees as the petitioner is being L3, without verifying the records as illegal, arbitrary and violation of articles 14, 21 and 300-A of Constitution of India also against the principles of natural justice and consequently direct the respondent No.2 to 7 to give opportunity to select outsourcing employees to the petitioner being a L3 in the Tender process,

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri. M A K MUKHEED Advocate for the Petitioner, Government Pleader for Education for respondent No.1, Mr.Mohd Shakheel, Standing Counsel for MGU for respondent Nos.2 to 5, Government Pleader for Labour for respondent Nos.6 and 7, directed issue of notice to the Respondent No.8 herein to show cause as to why this WRIT PETITION should not be admitted.

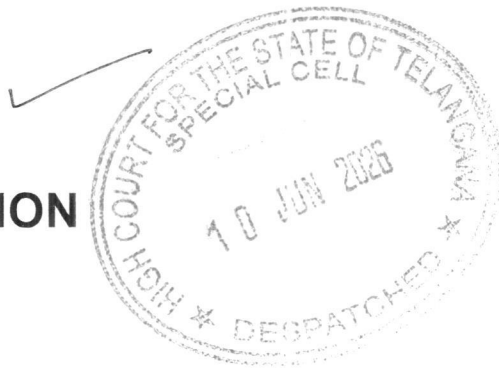
