This application is filed to recall the order dated 12.09.2025 passed by this Court, by which the writ petition was dismissed as infructuous.

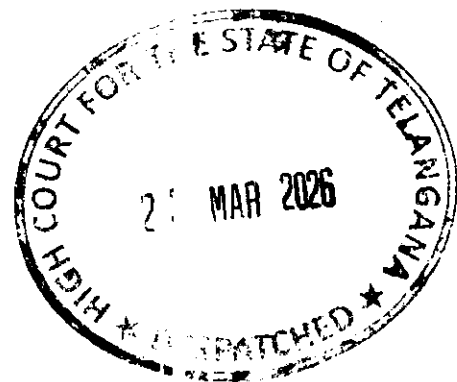
