GP for Home for the Respondents, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased direct the 4th Respondent not to call the petitioner to the police station, pending disposal of WP No 15969 of 2026, on the file of the High Court.

**Notice before admission.**

**Learned Assistant Government Pleader for Home takes notice on behalf of respondents. He seeks time to obtain instructions and make submissions.**

**Learned counsel for the petitioner submits that respondent No.4 is repeatedly calling the petitioner to Police Station, without assigning valid reasons and thereby interfering into the personal life and liberty of the petitioner due to which the petitioner is put to suffer severe mental agony and hardship. Therefore, he seeks to pass appropriate orders.**

**This matter requires detailed examination.**

**The facts can be ascertained only upon filing counter affidavit by respondents.**

**In the meantime, as an interim measure, respondent No.4 is directed not to interfere into the personal life and liberty of the petitioner herein except by following the procedure contemplated under law**
