WHEREAS the Petitioner above named through her Advocate SRI S.M.SAIFULLAH, presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ or direction more particularly one in the nature of Writ of Mandamus, declaring the action of the Respondent No. 3 and 4 in not acting upon the petitioners representation dated 18-04-2026 and 24-04-2026, seeking to stop the illegal and unauthorised construction being carried out by the Respondent No.5 and his henchmen in respect of agricultural land admeasuring a total extent of Ac. 0.27 guntas, comprising Ac. 0-23 guntas in Sy. No. 107/C and Ac. 0.04 guntas in Sy. No. 107/B and a total extent of Ac. 0.36 guntas, comprising Ac. 0-18 guntas in Sy. No. 120/A and Ac. 0-18 guntas in Sy. No. 120/B, situated at Irukulla village, Karimnagar Rural Mandal and District, Telangana despite the

Injunction Order passed in I.A.No. 10 of 2025 in OS.No. 43 of 2025, on the file of the I Addl. Junior Civil Judge, Karimangar, as illegal, arbitrary, unconstitutional, violative principles of natural justice besides violation of Article 14 and 21 of the constitution of India and contrary to the provisions of Telangana Panchayath Raj Act 2018 and consequently direct the Respondents to forthwith stop the ongoing illegal construction in the subject property.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI S.M.SAIFULLAH, Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
