presence of the petitioners is required, they shall appear before the trial Court. In case of their non-appearance on the specific date fixed by the trial Court for their appearance, the trial Court is entitled to proceed with the matter, in accordance with law.

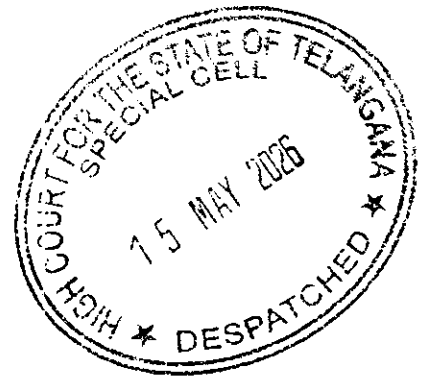
