Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Writ order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondents in placing the non PSC candidates who were appointed as AEs by transfer under 20% quota without calculating the substantive vacancies earmarked for such method of appointment, (feeder category) above the names of the 2011 batch AEs of Zone-V in terms of G.O.Ms No. 56 dated 24-7-2017 by violating the Rules in

G.O.Ms.No. 77 dated 17-3-2012 without finalising the provisional seniority list dated 14-12-2015 in terms of G.O.Ms.No. 77 dated 17-3-2012 as illegal, arbitrary, unjust and contrary to Article 14 & 16 of the Constitution of India and consequently direct the respondents to revise the provisional seniority list dated 14-12-2015 & 3-10-2017 in terms of Rules in G.O.Ms.No. 77 dated 17-3-2012 and placing the 2011 batch AEs of Zone-V above the non PSC promotee candidates in the seniority list w.e.f 14-12-2015 duly following the Rules in G.O.Ms.No. 77 from the date of provisional seniority list dated 14-12-2015 by pushing down the excess 20% quota transferee promotes and accommodated against substantive vacancies earmarked for such method of appointment (feeder category) and effect further promotions to the petitioners w.e.f 14-12-2015 from the date of issue of provisional seniority list.

This petition coming on for hearing, upon perusing the petition and affidavit filed in support thereof and upon hearing the arguments of SRI G. SAI PRASEN, Counsel on behalf of Petitioner in I.A.No.1 of 2024 and GP FOR SERVICES for the Respondent Nos. 8 & 9, the Court made the following: **ORDER**

"Heard Learned Counsel appearing for the petitioners.

Learned counsel for the petitioners filed I.A.No.01 of 2024 seeking permission of this Court to permit writ petitioner No.8 to withdraw the present writ petition.

Having regard to the reasons set out in the accompanying affidavit as well as the submissions made by the learned counsel for the petitioners, this application is ordered and the present writ petition is dismissed as withdrawn insofar as petitioner No.8 is concerned.

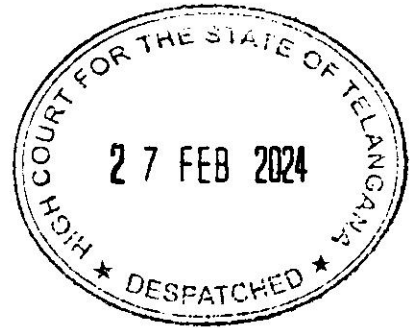
