WHEREAS the Petitioner above named through his Advocate Sri. IMMANENI RAMA RAO presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ order or direction more in the nature of a Writ of Mandamus declaring the action of respondents more particularly that of respondents 2 to 4 attempting to change the revenue entries in BHU BHARATI pertaining to land in Sy Nos 33/8 and 33/9 in Khata No 952 for land admeasuring Ac 1.2500 G in Sy No 33/8/3 Jeedimetla Village, Qutbullapur Mandal, Medchal Malkajgiri District,

without following the provisions of The Telangana Bhu Bharati (Record of Rights in Land) Act 2025 by issuing a notice or intimation more particularly sections 7, 8 and 9 of the act corresponding to earlier laws, in the benefit of unofficial respondent basing on an invalid, void, fake, fraudulent partition deed bearing 1597/1978 expressly barred as void under sections 7 and 26 of the Telangana Land Reforms (Ceiling on Agricultural Holdings) Act 1973 in consequence the 5th respondent causing interference by conducting inspection of subject property on 02.05.2026 without any notice, pending the disposal of suits in O.S No 466/2022 U.S Nos 466/2022 on the file of Learned I Additional Junior Civil Judge, Medchal Malkajgiri District at Medchal, O.S 182/2025 on the file of Learned Principal Senior Civil Judge Medchal Malkajgiri, where an interim order of status-quo as against the above said unofficial respondent stands granted pending the disposal, a suit in O.S No 203/2023 is pending on the file of Hon'ble District Judge, Medchal Malkajgiri, apart from O.S No 301/2025 on the file of Learned Senior Civil Judge, Medchal Malkajgiri, through the rights of petitioner are evidenced under the revenue records and assessed under PTIN Nos 1250407654, 1250407653, and 1250407655 with premises bearing Nos 7-910/12 & 13, 7-910/14 & 15, 7-910/16 & 17 apart from an interim direction in IA No 1/2022 in WP No 44290/2022 on the file of this Hon'ble Court, apart from WP No 28707/2025 as being illegal, arbitrary, and unconstitutional, being violative of Articles 14, 19 and 300-A of the Constitution of India, against the letter and spirit of the judgments rendered by the Hon'ble Supreme Court of India as well this Honorable Court apart from being violative of Principles of Natural Justice and fair play, and pass

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri. IMMANENI RAMA RAO Advocate for the Petitioner, Assistant Government Pleader for Revenue takes notice on behalf of respondent Nos. 1 to 5, directed issue of notice to the Respondent No.6, herein to show cause as to why this WRIT PETITION should not be admitted.

ORDER

Learned Assistant Government Pleader for Revenue takes notice on behalf of respondent Nos. 1 to 5.

Issue notice to respondent No.6.

Learned counsel for the petitioner is permitted to take out personal notice to respondent No.6 by Speed Post with Acknowledgment Due and file proof of service by the next date of hearing.

There shall be interim direction to respondent Nos. 2, 3 and 4 not to change revenue entries in Bhu Bharati portal in respect of land admeasuring Ac.1.2500 guntas in Survey No.33/8/3, situated at Jeedimetla Village, Quthbullapur Mandal, Medchal-Malkajgiri District, without issuing notice to the petitioner and without following the provisions of the Telangana Bhu Bharati (Record of Rights in Land) Act, 2025.

List the matter on 24.06.2026.
