Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to pass such an order or direction or writ, more so in nature of Writ of Mandamus declaring;

i. the action of Respondent No.3 in issuing proceedings/memo vide Rc.No.277/2015-H, dated 15.12.2023 cancelling all decisions taken in the meeting participated by MC Member G Srinivas Reddy including the membership of the Petitioners without issuing notice on the petitioners, as illegal, arbitrary, without jurisdiction and violation of principles of natural justice and;

ii. the action of Respondent No.2 in passing the impugned order vide Rc.No. 884/ 2015-HR2, dated 30.07.2025 rejecting the Petitioner's objections dt.19.06.2025, as illegal, arbitrary, and in violation of the principles of natural justice and Article 14 and 300A of the Constitution of India;

iii. and consequently set aside the impugned proceedings/memo dated 15.12.2023 issued by Respondent No.3 and the Order dated 30.07.2025 issued by Respondent No.2, and direct the Respondents to restore the petitioner's membership and include their names to the final voter list and permit them to vote in the ensuing elections to the 4th Respondent Society.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to suspend the operation of the impugned proceedings/memo dated 15.12.2023 vide Rc.No. 277/2015-H issued by the Respondent No.3 and restore the petitioner's membership and include their names to the final voter list and permit them to vote in the ensuing elections to the 4th Respondent Society, pending disposal of WP No 16172 of 2026, on the file of the High Court.

I.A. NO: 2 OF 2026

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to suspend the operation of the impugned order dated 30.07.2025 vide Rc.No. 884/2015-HR2 passed by the Respondent No.2 and restore the petitioner's membership and include their names to the final voter list and permit them to vote in the ensuing elections to the 4th Respondent Society, pending disposal of WP No 16172 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of SRI A. VENKATESH, SENIOR COUNSEL REPRESENTING SRI A. It is also observed that if any election schedule is released by the respondent No.4/TNGO's Cooperative House Building Society, liberty is given to the petitioner to move the Registry for hearing on priority basis.
