Y. presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, declaring the action of the 2nd Respondent in passing the impugned order bearing Proceedings No.B2/0118/47/2025 dated 18.03.2026, as being contrary to the provisions of Telangana Maintenance and Welfare of Parents and Senior Citizens Act, 2007, apart from being arbitrary, without jurisdiction and violative of Article 14 and 21 of Constitution of India and consequently set aside the same by directing cancellation of the

There shall be interim direction to respondent Nos.4 to 7 not to alienate or create any third party interest in respect of land admeasuring Ac.0-07 guntas, Ac.0-08 guntas,

Ac.0-32½ guntas and Ac.0-09 ½ guntas in Survey Nos.50/1, 6/EE, 428/AA/2 and 5/A situated at Chinthaguda Shivar, Jannaram Mandal, Mancherial District.

List the matter on 01.07.2026.
