WHEREAS the Petitioner above named through his Advocate Sri. P CHAITHANYA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of writ of Mandamus declaring the action of the 2nd respondent in issuing PTIN No. 1212410980, in respect of H.No.11-236/A/2, situated at Somavaram Village, Wyra Mandal, under Wyra Municipality, Khammam District, which forms Part of Suit Schedule Properties in O.S.No. 127/2024, pending on the file of the Senior Civil Judge, Madhira, inspite of petitioner making specific representations dated 18.06.2024, 09.12.2024 & 11.01.2025 as highly illegal, arbitrary and in violation of Article 300-A of the Constitution of India, contrary to Doctrine of Lis Pendens, consequently direct the 2nd respondent to forthwith revoke the PTIN No. 1212410980, issued in the name of the 3rd respondent, in respect of H.No.11-236/A/2, situated at Somavaram Village, Wyra Mandal, under Wyra Municipality, Khammam District,

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri. P CHAITHANYA Advocate for the Petitioner, Government Pleader for Municipal Administration & Urban Development for respondent No.1, Mr. Laxmaiah Kanchani, Standing Counsel for Municipalities for respondent No.2, directed issue of notice to the Respondent Nos.3 & 4 herein to show cause as to why this WRIT PETITION should not be admitted.
