Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ or an order or a direction, more particularly a writ in the nature of Mandamus by declaring the actions of the Respondents in blocking the Petitioner lands admeasuring Ac. 1-20 Gts in 364/p (erroneously reflected in the records as Sy. No. 365/U/1), situated in Bommaraspet Village, Shamirpet Mandal, Medchal Malkajgiri District on Bhu Bharathi Portal by reflecting transaction status as Ongoing transaction on Survey no/Sub-division no with application number RC2300005437 in Application for Court - Passbook process as being illegal, arbitrary unconstitutional, contrary to the provisions of the Telangana Bhu Bharati (Record of Rights in Land) Act, 2025 and consequently direct the Respondents herein to delete the same from Bhu Bharathi Website / Portal.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the Respondent Authorities not to incorporate or affect changes in respect of Petitioner's land admeasuring Ac. 1-20 Gts in Sy. No. 364/p (erroneously reflected in the records as Sy. No. 365/ U/1), situated in Bomraspet village, Shamirpet Mandal, Medchal - Malkajgiri District, Pending disposal of WP 16611 of 2025, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri M PRANAV Advocate for the Petitioner, GP FOR REVENUE Advocate for the Respondents and the Court made the following.

ORDER

Sri Avinash Desai, learned Senior Counsel representing Sri Mr. Pranav, learned counsel for the petitioner has submitted that earlier some persons have filed W.P.Nos. 36347, 36348 of 2022 and 13522 of 2025 for the very same subject land, wherein this Court has granted interim orders and prayed to pass the same order in this writ petition.

Sri L. Ravinder, learned Assistant Government Pleader for Revenue, who takes notice for the respondents, has not disputed the said fact and seeks time to file counter-affidavit.

In view of the above submissions, pending filing of the counter-affidavit, there shall be interim direction to the respondents not to incorporate or effect any changes in the revenue records in respect of the subject land.
