WHEREAS the Petitioner above named through his Advocate SRI MALIPEDDI SRINIVAS REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ order or direction more particularly a Writ in the nature of Mandamus directing the Respondents more particularly Respondent No 4 to act in accordance with law and forbear from demolishing watchman room and other temporary structures in the stilts in Gokul Enclave Apartments H. No. 32-981,982, 983, North HAL Colony, Gajularamaram, Medchal, Malkajgiri District without following the procedure of Law and without notifying the Petitioner about the alleged invalidity in the structures, as the same being violative of principles of natural justice and violative of Articles 14, 21 and 300 A of the Constitution of India and also contrary to the provisions of the Greater Hyderabad Municipal Corporation Act in the interest of justice.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI MALIPEDDI SRINIVAS REDDY Advocate for the Petitioner and GP FOR MUNICIPAL ADMINISTRATION AND URBAN DEVELOPMENT for the Respondent no.1 and SRI K. RAVI MAHENDER, Standing Counsel for CYBERABAD MUNICIPAL CORPORATION for the Respondents no. 2 to 4 directed issue of notice to the Respondents no. 5 and 6 herein to show cause as to why this WRIT PETITION should not be admitted.

In the meantime, the official respondents are directed not to take any coercive steps against the petitioner in respect of the subject property.
