Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ or order or direction more particularly one in the nature of Writ of Mandamus declaring action of the respondents herein more particularly the respondents 3 and 4 herein in harassing the petitioner under the guise of special drive against the rowdy sheeters, thereby interfering into the personal life and liberty of the petitioner by subjecting the petitioner to both physical and mental torture as unjust, illegal, arbitrary, violative of principles of natural justice, provisions of Criminal Procedure Code and violation of Articles 14, 15, 16 and 21 of Constitution of India and consequently direct the respondents 3 and 4 not to interfere with the personal life and liberty of the petitioner by visiting him in the odd hours in the name of surveillance under the guise of special drive and not to call him to the police station without following due process of law in the interest of justice.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents herein to produce the CC TV footage of PS Habeebnagar i.e Parking area, 1 St Floor and 2nd Floor pertaining to 29/06/2024 between 12.00 AM till 7.00 PM., Pending disposal of WP 17135 of 2024, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of SRI M A MUJEEB Advocate for the Petitioner, GP FOR HOME for the Respondent Nos. 1 to 4 and the Court made the following.

ORDER

Respondent Nos.3 and 4 - the Additional Deputy Commissioner of Police, South-West Zone, Hyderabad, and the Inspector of Police, Habeebnagar Police Station, Hyderabad, are directed not to call the petitioner to the Police Station and not to interfere with his personal liberty unless he is involved in two (2) pending cases and the conditions prescribed in Standing Order 601 of the Telangana Police Manual are attracted.
