WHEREAS the Petitioner above named through their Advocate SRI P V RAMANA presented this Petition under Article 226 of the Constitution of India

praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ of Mandamus declaring the orders passed by the 2nd Respondent proceedings No.HR2/013/2024/CONV/ESTT/2025-26 dated 16.04.2026 acting upon the representation of the unofficial Respondents for their conversion from the category of Senior Personal Secretaries to the category of Senior Secretarial Assistant from the date 27.02.2021 of their regular appointment by promotion as Senior Personal Secretaries is illegal, arbitrary, violates Articles 14, 16 and 21 of the Constitution of India and consequentially declare the authorities under institute have no power, jurisdiction, authority to pass such an order granting retrospective conversion from 27.02.2021 and counting the said service for the purpose of further promotions to the post of Superintendents and higher categories.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. P V RAMANA Advocate for the Petitioners and ASST GP FOR SERVICES I, for the respondent No.1, directed issue of notice to the Respondent Nos. 2 to 9, herein to show cause as to why this WRIT PETITION should not be admitted.
