WHEREAS the Petitioner above named through his Advocate Sri BEGARI SRIKANTH presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondent Nos. 2 to 4 in trying to dispossess the petitioner from his agriculture land in Sy.No.13 to an extent of Ac.3.13 gts situated at Ghatkesar Revenue Village, Ghatkesar Mandal, Medchal-Malkajgiri District, without issuing any notice, without following due process of law, by colluding with the unofficial respondent No.5, violation of Principles of Natural Justice and also violation of Articles 14 and 300-A of the Constitution of India and consequently direct the respondent Nos.2 to 4 to consider the petitioner representations on Dated 05.05.2026 and not to dispossess the petitioner from his agriculture land in Sy.No.13 to an extent of Ac.3.13 gts situated at Ghatkesar Revenue Village, Ghatkesar Mandal, Medchal-Malkajgiri District to follow due process of law.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. BEGARI SRIKANTH Advocate for the Petitioner, GP FOR REVENUE, for the respondent Nos. 1 to 4, directed issue of notice to the Respondent No.5 herein to show cause as to why this WRIT PETITION should not be admitted.

Pending consideration of the online application submitted by the petitioner bearing No.2400074913 dated 04.08.2024 for issuance of e-pattadar pass book in respect of the land admeasuring Acs.3-13 guntas in Survey No.13, situated at Ghatkesar Revenue Village, Ghatkesar Mandal, Medchal-Malkajgiri District, *status quo* obtaining as on today shall be maintained in respect of the subject land.
