WHEREAS the Petitioner above named through his Advocate Sri P RAMA SHARANA SHARMA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to pass an order or direction or writ in the nature Mandamus duly declaring the action of the respondents in not conducting the survey of land vide Acres 5-00 Gts, in Survey Number 999/34, situated in Bangarujala Village of Palvoncha Mandal despite F-line application vide No. ROS022003713151, dated 09.11.2020 and in not issuing the 1-B, and e-Pattadar Pass Book for the said land as illegal, arbitrary and against the principles of natural justice and consequently direct the respondents to forthwith consider the F-Line application and conduct the survey as well as issue 1-B, as well -PPB for the above lands to the petitioner in the interest of justice,

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri P RAMA SHARANA SHARMA Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

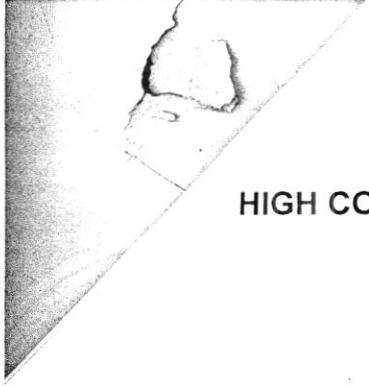
