Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ Order or Direction more particularly one in the nature of Writ of Mandamus declaring the action of the Respondents particularly Respondent No.5 in illegally entering into and demolishing the crusher units machinery structures and infrastructure situated in the Subject Property i.e., land admeasuring Ac 23-19 guntas in Sy.No.69 situated at Kothwalguda Village, Shamshabad Mandal, Ranga Reddy District, on 09.05.2026, without issuing any notice and without following due process of law as illegal arbitrary unconstitutional violative of Articles 14 21 and 300-A of the Constitution of India and contrary to the principles of natural justice.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondents more particularly Respondent No5 not to interfere with the

peaceful possession and enjoyment of the Petitioner over the Subject Property situated in Sy No 63 admeasuring Ac 3-13 Gts and Sy No 69 admeasuring Ac 23-19 Gts of Kothwalguda Village Shamshabad Mandal Ranga Reddy District, pending disposal of WP No 16688 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the petition and the AFFIDAVIT filed in support thereof and upon hearing the arguments of M/s. Pillix Law Firm Advocate for the Petitioners, GP FOR REVENUE for the Respondents, the Court made the following;

ORDER:

Heard Mr. Mayur Reddy, learned Senior Counsel for the petitioner, learned Assistant Government Pleader for Revenue for the respondent Nos.1 to 4 and Mr. R. Sameer Ahmed, learned Standing Counsel for HYDRAA, for the respondent No.5.

Learned Assistant Government Pleader for Revenue for the respondent Nos.1 to 4 has placed on record written instructions duly signed by the Tahsildar, Shamshabad Mandal, Ranga Reddy District, dated 14.05.2026.

Mr. R. Sameer Ahmed, learned Standing Counsel for HYDRAA, for the respondent No.5 has placed written instructions today.

Learned Senior Counsel for the petitioner submits that the petitioner shall not undertake illegal stone crushing units at subject property i.e. land admeasuring Ac.23-19 guntas in Sy.No. 69 situated at Kothwalguda Village, Shamshabad Mandal, Ranga Reddy District.

Similarly, Mr. R. Sameer Ahmed, learned Standing Counsel for HYDRAA, for the respondent No.5 undertakes that they shall not interfere with the peaceful possession and enjoyment of the petitioner over the subject property.

The submissions of both the learned counsel has been taken on record.

Learned Assistant Government Pleader for Revenue for the respondent Nos.1 to 4 and learned Standing Counsel for HYDRAA, for the respondent No.5 seeks six weeks time to file their counter affidavits.
