Heard Mr. Ch.Ravi Kumar, learned counsel for the appellants and  
Mr. Mulugu Srikanth Reddy, learned counsel for respodnent No.8.

2. Learned counsel for the appellants submits that the interim order dated 02.04.2026 granted in W.P.No.10173 of 2026 has not been extended on 06.05.2026 and the matter was simply adjourned to 09.06.2026. Learned counsel for the appellants further submits that there was no adjudication of the matter and no hearing was held and no order formally adjudicating the issue involved was made. In that view of the matter, he prays that the interim order



dated 02.04.2026 be extended until Summer Vacation and the matter be taken up on 09.06.2026, to which date the matter otherwise stands posted.

3. Accordingly, the Writ Appeal is disposed of with the direction that the interim order dated 02.04.2026 granted in W.P.No.10173 of 2026 shall stand extended till 09.06.2026. There shall be no order as to costs.
