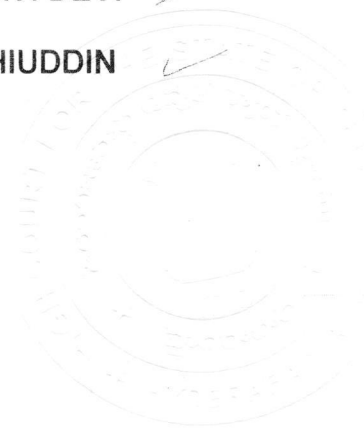

Appeal under Clause 15 of the Letter Patent Act, praying that in the circumstances stated in the appeal and the grounds filed therein, the High Court may be pleased to allow the Writ Appeal and set aside the Order Dated 30-04-2026 Passed in W.P.NO14026 OF 2026.

I.A. NO: 2 OF 2026

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondents not to interfere with the cultivation by the petitioners of their respective subject lands situated in Yelgoi Village, Jharasangam Mandal, Sangareddy District, that are under acquisition vide declaration Proc.No.G1/1190/2018 dt.23.02.2026, Pending disposal of WA No 537 of 2026, on the file of the High Court.

The appeal coming on for hearing, upon perusing the appeal and the grounds filed in support thereof and upon hearing the arguments of Ch Ravi Kumar, Advocate for the Appellants and the Spl. GP representing the Advocate General for the Respondent Nos.1 to 7 and Sri M. Srikanth Reddy, Advocate for the Respondent No.8, the Court made the following.

ORDER

Learned counsel for the appellants has raised multiple grounds with regard to the acquisition of the property of the appellants including the defects in the process of acquisition. Learned counsel further submits that the balance of convenience is overwhelmingly in favour of the appellants in as much as an irreparable loss would be caused to the appellants if they are not allowed to harvest standing crops. Learned counsel seeks a month's time to enable the standing crops to be harvested.

In the meanwhile, the respondents shall not interfere with the harvesting of the agricultural produce.

Learned Special Government Pleader has pointed out that the panchanama in respect of the property of the appellants has already been conducted and that the money has already been deposited to the account of the appellants. Learned Special Government Pleader further contends that once the panchanama has been completed and the awarded amount has been deposited into the account of the appellants, the possession of the subject land is deemed to have been vested with the State.

List the WP. No. 14026 of 2026 on 10.06.2026 before the learned Single Judge for 'final disposal'.

Learned Single Judge shall endeavor to dispose of the writ petition as expeditiously as possible.

This order is passed in view of the exceptional circumstances obtaining in the facts and circumstances of this case and it shall not constitute the precedent.
