WHEREAS the Petitioner above named through his Advocate SRI KONGALA MOHAN GOUD, presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ order or direction more particularly one in the nature of writ of Mandamus to declare the action of the Respondent No.2 and 3 on 10.05.2026 with lack of jurisdiction and without following due procedure of law involving in civil disputes on the false complaints of the unofficial respondents No. 4 and 5 over the subject property making them to sit in the police station and insisting the writ petitioner to settle the disputes with them, hence the same is arbitrary, illegal and unconstitutional and violative of Articles 21 and 300-A of Constitution of India and consequentially direct the Respondent No.2 and 3 not to cause any hardship in the name of enquiry on the false complaints of the unofficial respondent No.4 and 5.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI KONGALA MOHAN GOUD Advocate for the

Petitioner and AGP FOR HOME for the Respondents no. 1 to 3 directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

**The Court made the following**

**ORDER:**

**Notice before admission.**

**Learned counsel for the petitioner is permitted to take out personal notice on respondent Nos.4 and 5 by way of Speed Post with Acknowledgment Due and shall file proof of service in the Registry.**

**Learned counsel for the petitioner submits that the respondents/Police have been interfering with the private property disputes. The learned counsel further submits that a direction may be issued to the Police concerned, to follow the provisions of BNSS, 2023 and the guidelines laid down by the Hon'ble Supreme Court in *Arnesh Kumar v. State of Bihar*<sup>1</sup>.**

**On the other hand, the learned Assistant Government Pleader for Home, submits that a complaint has been lodged by respondent No.4 against the petitioner herein at which time an investigation may have been undertaken. The said complaint was subsequently withdrawn.**

**The police are not interfering with the private property disputes of the petitioner. The said submission is taken on record.**
