WHEREAS the Petitioner above named through its Advocate SRI. G L NARASIMHA RAO presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High

Court may be pleased to issue any appropriate writ order or direction one more particularly one in the nature of WRIT OF MANDAMUS,

1) declaring the inaction of the respondents in implementing the law and orders regarding , not to enter in to the GHMC limits as per the Sec. 510 of GMC Act take action as per Section 540 of GHMC Act,

2) Directing the respondents to take action, not to hoarded or slaughter any single cattle on the GHMC public Roads and Houses, on 26 to 28th of May 2026 on event of Bakrid 2026,

3) Direct the respondents to save the cattle which came in to Hyderabad city on 10-5-2026 and 17-5-2026 hoarded in private Shelters /sheds to slaughter on eve of Bakrid scheduled on 26th to 28 th May 2026 Without permission granted by the competent authority as per the Sec. 510 and 540 of GHMC Act as per Law and to seize all the cattle i.e, cows calf's bulls bullocks buffaloes etc., which have been illegally transported and entered in to Greater Hyderabad limits without proper permissions and certificates including from a veterinary doctors for fit for slaughter.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. G L NARASIMHA RAO Advocate for the Petitioner, Government Pleader for Municipal Adrnistration for respondent No.1, Assistant Government Pleader for Home for respondent Nos.3 and 4, learned standing counsel for GHMC for respondent Nos.2, 5, 6 and 8, learned standing counsel for Animal Welfare Board for respondent No.7, and Government Pleader for Animal Husbandry for respondent No.10, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
