WHEREAS the Petitioners above named through their Advocate Sri POCHAIHAH DORISHETTI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue appropriate writ, order or orders, more particularly one in the nature of writ of mandamus declaring the action of the respondent No. 3 in issuing notice dt 14/05/2026 is illegal, arbitrary and violative of Article 21 and 300 -A of the constitution of India and consequently direct the
