Petition under Article 226 of the Constitution of India, praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Writ, Order or Direction, or any other appropriate Order one in the nature of WRIT OF MANDAMUS, declaring the action of the Respondent No.2 issuing Show Cause Notice vide Notice No.G1/294-1/UC/TPS/2026 dated 15.04.2026 to the Petitioners without mentioning their names, also issuing Confirmation Notice vide No.G1/241/1/1/UC/TPS/2026, No.G1/241/2/1/UC/TPS/2026 dated 13.05.2026, No.G1/241/3/1/UC/TPS/2026 dated 13.05.2026, threatening to demolish the Petitioners' properties in Part of Sy.No.123, altogether admeasuring 1340 Sq yards, situated at main Road Huzurnagar, Suryapet District, Telangana State, by visiting the property on 25.05.2026 with demolition material without following due process of law and without considering the reply given by the Petitioners to the Show Cause Notice issued by the Respondent No.2 as illegal, arbitrary and violation of articles 14, 21 and 300-A of Constitution of India also against the principles of natural justice

and consequently set aside the Show Cause Notice vide Notice No.G1/294-1/UC/TPS/2026 dated 15.04.2026 issued by the Respondent No.2 to the Petitioners without mentioning their names. also issuing Conformation Notice vide No.G1/241/1/1/UC/TPS/2026. No.G1/241/2/1/UC/TPS/2026 dated 13.05.2026. No.G1/241/3/1/UC/TPS/2026 dated 13.05.2026 by directing the Respondent No.2 not to demolish the Petitioners' properties in Part of Sy.No.123, altogether admeasuring 1340 Sq yards, situated at main Road Huzurnagar, Suryapet District, Telangana State:

Petition under Section 151 of C.P.C, praying that in the circumstances stated in the affidavit filed in the writ petition, the High Court may be pleased to suspend the Show Cause Notice vide Notice No.G1/294-1/UC/TPS/2026 dated 15.04.2026 issued by the Respondent No.2 to the Petitioners without mentioning their names. also issuing Conformation Notice vide No.G1/241/1/1/UC/TPS/2026. No.G1/241/3/1/UC/TPS/2026 dated 13.05.2026 by directing the Respondent No.2 not to demolish the Petitioners' properties in Part of Sy.No.123, altogether admeasuring 1340 Sq yards, situated at main Road Huzurnagar, Suryapet District, Telangana State, pending disposal of WP No. 16880 of 2026, on the file of the High Court.
