WHEREAS the Petitioner above named through their Advocate Sri. N PRAMOD presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased issue an appropriate Writ, Order or Direction more particularly one in the nature of Writ of Mandamus declaring the action of respondent No. 4 to 8 in interfering with peaceful possession and enjoyment of the respective plots of the petitioners, at the behest of respondent No.10 under the guise of interim orders passed in W.P.No.7576 of 2026 without being circumspective of the intent of the order and supporting the respondent No. 10 and altering the physical features of the subject properties by removing the structures, the boundary stones and also clearing the reclaiming the property which is shown to be as Housing plots in subsisting layout and causing damage to the entire property to erase the identity and location of the respective plots, despite of the orders of subsisting injunction ad interim orders in respect of the housing plots granted by competent Civil Courts in favour of the petitioners, as illegal, arbitrary, unconstitutional and violative of Articles 14, 21 and 300-A of the Constitution of India and consequently direct the respondents not to interfere with the peaceful possession and enjoyment of the petitioners except by due process of law.

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri. N PRAMOD Advocate for the Petitioner, Government Pleader for Revenue for respondent Nos.1 to 4, Government Pleader for Home for respondent Nos.5 to 8, directed issue of notice to the Respondent Nos.9 & 10 herein to show cause as to why this WRIT PETITION should not be admitted.
