Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondent No. 2 to 4 in not considering the petitioner's representation dt.17/06/2019, 25/04/2020 and 20/04/2019 with regard to issuance of pahani, 07/02/2019 and pattadar pass book in favour of respondent No.6 to 9 with regard to an extent of Ac.3.16 gts in Sy.No.715, situated at Kotya Naik Thanda, H/o Pocharam Revenue Village, Garla Mandal, Mahabuababad District is illegal, arbitrary, unjust and against the Article 14,21 and 300-A of the Constitution of India and also against the principles of natural justice and consequently direct the respondents No.4 to set aside the pahanies and pattadar pass book issued in favour of respondent No.6 to 9 with regard to petitioner's land to an extent of Ac.3.16 gts in Sy.No.715, situated at Kotya Naik Thanda, H/o Pocharam Revenue Village, Garla Mandal, Mahabuababad District.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents No.2 to 4 to consider the representation of the petitioner dt.17/06/2019, 25/04/2020 and 20/04/2019 for cancellation of pahani and pattadar issued in favour of respondent Nos. 6 to 9 and issuance of new pass book and pahani in favour of petitioners herein who are legal heirs of Late Mood Mangyal, pending disposal of WP 17984 of 2024, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of SRI JOGRAM TEJAVAT Advocate for the Petitioners, GP FOR REVENUE for the Respondents and the Court made the following.

**ORDER**

**No representation on behalf of respondent No.6.**

There shall be interim direction to respondent No.4 to consider the representation of the petitioner dated 17.06.2019 for correction of revenue records pertaining to the land admeasuring Acs.3-16 guntas in Survey No.715 situated at Kotya Naik Thanda, H/o. Pocharam Village, Garla Mandal, Mahabubabad District, and pass orders, in accordance with law, by issuing notice to the petitioner, respondent Nos.5 to 9, and all other concerned/interested persons, by affording opportunity of hearing to them, within a period of six (6) weeks from the date of receipt of a copy of this order.

List the matter on 22.07.2026.
