WHEREAS the Petitioner above named through his Advocate SRI SEETHARAM REDDY KANCHARLA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or direction, more particularly one in the nature of Writ of Mandamus not to declare the action of the 2nd Respondent for not to consider Petitioner's Register Post complaint filed on 21/05/2026 and trying to dispossess the Community Dhobhi Ghat for an extent of Ac 2.05 Gts in Sy No. 698/AA situated Ramannapet Revenue Village and Mandal, Yadadri Bhongir District and consequently direct the 2nd Respondent for not to dispossess Petitioner from the Dhobhi Ghat for an extent of Ac 2.05 Gts in Sy No. 698/AA situated Ramannapet Revenue Village and Mandal, Yadadri Bhongir District.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI SEETHARAM REDDY KANCHARLA Advocate for the Petitioner and AGP FOR HOME for the Respondents no. 1 and 2 directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

are directed to show cause on or before 16.06.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the 2nd Respondent for not to dispossess Petitioner from the Dhobhi Ghat for an extent of Ac 2.05 Gts in Sy No.698/AA situated Ramannapet Revenue Village and Mandal, Yadadri Bhongir District, pending disposal of WP No 17077 of 2026, on the file of the High Court.

The Court made the following

ORDER:

Notice before admission.

Learned Assistant Government Pleader for Home takes notice on respondent Nos.1 and 2.

Learned counsel for the petitioner is permitted to take out personal notice on respondent No.3 and file proof of service by the next date of hearing.

The primary grievance of the petitioner is that the respondent No.2 under the guise of respondent No.3 is interfering in the civil dispute and is trying to dispossess the petitioner from the land admeasuring to an extent of Ac.2.05 gts in Sy.No.698/AA, situated at Ramannapet Village and Mandal, Yadadri Bhongir District. Aggrieved by the same, the present writ petition is filed.

Learned Assistant Government Pleader for Home appearing for respondent Nos.1 and 2 on instructions would submit that the respondent No.3 lodged a complaint dated 13.05.2026, stating that after obtaining permission from the Gram Panchayat, respondent No.3 was constructing a house in the Grama Kantam land, situated at Sy.No.698 and the petitioner trespassed the said land and is obstructing the construction made by respondent No.3. On such complaint, respondent No.2 made a petition entry vide ID.No.YDDB/RPT-RCHKD/150526/00325 dated 15.05.2026. It is further submitted that except conducting enquiry, the respondent authorities are

neither interfering in the civil dispute nor dispossessing the petitioner from the subject property.

Heard and perused the material available on record.

Prima facie, it appears that the patta said to have been granted in favour of respondent No.3 does not contain survey number and admittedly the petitioner is in possession of the subject property covered by Sy.No.698/AA, situated at Ramannapet Village and Mandal, Yadadri Bhongir District.

Matter requires examination.

Meanwhile, the respondent authorities are directed not to interfere with the civil dispute between the petitioner and respondent No.3, without following the due procedure as contemplated under law.
