WHEREAS the Petitioner above named through its Advocate M/s D. KRISHNA MURTHY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ of Mandamus or any other appropriate Writ Order or direction, direction declaring the inaction on the part of the respondents 2 to 4, in protecting the lands earmarked for Parks and other amenities in the Final Lay-out approved by vide Permit No.7123/95 -Letter No.7123/MP2/HUDA/95 dated 14-06-1996 released vide Proc. No. G-156/LP/1139/96 dated 23-12-1996 as illegal and arbitrary and issue a consequential direction to the respondents 2 and 3 (1) to protect the land earmarked for Parks and other amenities in the Lay-Out by constructing a compound wall around the open spaces reserved for Parks and amenities for communal purposes and (2) Direct the respondents 2 to 4 not to accord any building permission in respect of the open lands reserved for parks and amenities as per the Final Lay-Out dated 14-06-1996.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of M/s D. KRISHNA MURTHY Advocate for the Petitioner, directed issue notice to the Respondent Nos.5 to 7 herein to show cause as to why this WRIT PETITION should not be admitted.
