List this matter on 21.04.2026. Till such time, interim order granted earlier is extended.

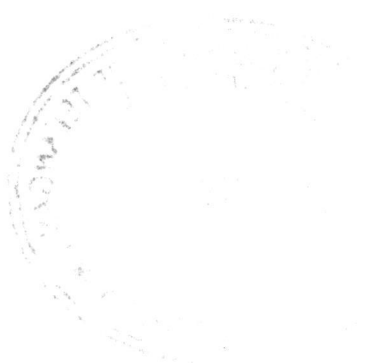
