the Contempt of Courts Act, 1971, for non-compliance of the above said order, by filing a counter-affidavit on or before 18-07-2025, failing which, she shall appear before this Court on that date at 10:30 A.M.

It is made clear that if the counter-affidavit is not filed on the date specified, the same shall not be accepted without payment of costs of Rs. 10,000/- to the Registrar (Judicial) by the respondent.

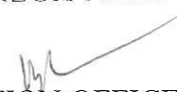
