WHEREAS the Petitioner above named through his Advocate Mr. SOMA RAVI KIRAN REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly a Writ in the nature of Mandamus declaring the action of Respondent No. 4 in attempting to forcibly dispossess the Petitioner from his agricultural land admeasuring 1.16 Guntas in Survey No. 278 (Sy.No.260/1) situated at Limba (K) Village, Kuntala Mandal, Nirmal District, without following the due process of law and without issuing any statutory notice, as illegal, arbitrary, unconstitutional, and in violation of Articles 14 and 300A of the Constitution of India. consequentially direct the Respondent No. 4 to refrain from interfering with the Petitioner's peaceful possession, enjoyment, and cultivation of the subject land admeasuring 1.16 Guntas in Survey No. 278 (Sy.No.260/1) situated at Limba (K) Village, Kuntala Mandal, Nirmal District.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Mr. SOMA RAVI KIRAN REDDY Advocate for the Petitioner, directed issue of notice to the Respondent No.5 herein to show cause as to why this WRIT PETITION should not be admitted.
