WHEREAS the Petitioners above named through their Advocate Sri KOPPULA GOPAL presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the proceedings case No. A3/1620/2024 dated 29.04.2026 which was received on 07.05.2026 issued

by the 2nd respondent herein directing the petitioners herein shall vacate the house bearing No. 5-7-376 situated at Sri Ram Nagar Colony, Saheb Nagar Kalan, Hayathnagar Mandal, Ranga Reddy District without following the observations made by this Hon'ble Court by order dated 12.08.2025 passed in W.P No. 21523 of 2025 and without giving an opportunity and without following the procedure is being illegal, arbitrary, unreasonable and violative of principles of natural justice and violation of Article 14 and 21 of the Constitution of India and contrary to the provisions contemplated under MWPSA Act, 2007 and rules made thereunder and contrary to the judgment of the Hon'ble Supreme Court reported in 2025 live law (SC) 445 and contrary to the order dated 12.08.2025 passed in WP No. 21523 of 2025 and consequently set aside the same.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. KOPPULA GOPAL Advocate for the Petitioners and Government Pleader for Revenue for Respondent Nos.1 to 4 directed issue of notice to the Respondent No.5 to show cause as to why this WRIT PETITION should not be admitted.
