**Except the learned counsel for the legal heirs of the deceased petitioner No.15, none appeared for the other petitioners.**

**Learned counsel for the unofficial respondents submits that several petitioners were withdrawn the writ petition by filing I.As, and seeks time to get instructions with regard to the contesting parties in the matter.**

**It is brought to the notice of this Court that the Registry is not carried out about withdrawal of the petitioners in the cause title of the writ petition.**

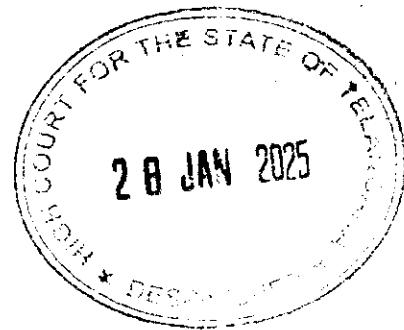
