D L PANDU presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, declaring the action of the respondents in not implementing the proceedings in Proc.No.48/D/2023 dated 16.06.2025 issued by the 3rd respondent pursuant to Memo No.732/E2/2024 dated 03.06.2025 and in not extending consequential membership rights, catching of the fishes in the Fishermen Cooperative Society Ltd., Gadi Peddapur Village, Alladurg Mandal, Medak District and other benefits to the petitioners and other approved members as illegal, arbitrary and violative of Articles 14, 19(1)(g) and 21 of the Constitution of India and consequently direct the respondents to forthwith implement the said proceedings by recognizing the petitioners as members of the Fishermen Cooperative Society, GadiPeddapur Village, Alladurg Mandal, Medak District as per the Proc.No.48/D/2023 dated 16.06.2025 issued by the 3rd respondent and extend all consequential benefits,

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri. D L PANDU Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
