praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction more particularly one in the nature of Writ of Mandamus declaring the action of the Respondents No.5 in withholding the Petitioners original Certificates as illegal, unjust and violation of principles of natural justice and restrain the institution/Colleges from withholding original certificate due to outstanding amounts for the Government or any including unpaid fees and regulations mentioned under Rule 2(F)(6) and Rule.4© issued by UGC notification vide file No.14-4/2012(CPP-1)in October 2018and Cir. No. JNTUH/DAAA/Students/Fee Reimbursement/2024, Dated 07/03/2024 an violations issued by Respondent No.4 and AITCE Circular F.No1-101/DPG/AITCE/Regulations/2019 dated 29/03/2019 and violation of Article.14,19 and 21 of Constitution of India ,Consequently direct the Respondents to issue all the Original Certificates including Long Memo, Study And Conduct Transfer Certificate of SSC, Intermediate. All Semesters Memo, and Bonafide Certificates along Provisional and Consolidated Marks Memos of Engineering are holding with Respondent No.5,

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri. Y V S S SIVA SARMA Advocate for the Petitioner, Sri Prabhakar Peri, Standing Counsel for Jawaharlal Nehru Technological University for respondent No.4, directed issue of notice to the Respondent No.5 herein to show cause as to why this WRIT PETITION should not be admitted.
