ORDER:

Vide impugned judgment and decree dated 30.06.2025, the learned trial Court decreed the suit filed by the respondent for an amount of Rs.41,65,254/- along with interest @ 6% per annum from 02.11.1999 till the date of realization. Several grounds

and contentions raised by the parties can be considered at the time of final hearing of the appeal.

Therefore, there shall be an interim suspension of the impugned judgment and decree dated 30.06.2025 on the condition of petitioner depositing 50% of the claim amount i.e., Rs.41,65,254/- and also the costs of Rs.2,133/- to the credit of the said suit within a period of four (04) weeks.
