WHEREAS the Petitioner above named through its Advocate SRI SRINIVAS KAVALI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to Issue a Writ, Order or Direction one in the nature of WRIT OF MANDAMUS,

A. Declaring the action of the Respondents No.2 and 3 in awarding the contract dated 01.06.2026 in favour of the 4th Respondent, pursuant to the Third Tender dated 20.04.2026 Tender Notification No. 056/Admn./PU/2026 / 3rd Call, as illegal, arbitrary and violative of Article 14 of the Constitution of India, being contrary to the principles of transparency, fairness, and equal treatment in public procurement;

B. Consequently, direct the Respondent No. 2 and 3 to Initiate a fresh re-tender process and provide the Petitioner a fair opportunity to participate in the re-tender process without discriminatory eligibility barriers in the interest of justice.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI SRINIVAS KAVALI Advocate for the Petitioner, SRI K. SHARATH, AGP FOR HIGHER EDUCATION for the Respondent no.1, SRI T. VENKAT REDDY, Standing Counsel for PALAMURU UNIVERSITY for the Respondents no. 2 and 3 directed issue of notice to the Respondent No.4 herein to show cause as to why this WRIT PETITION should not be admitted.
