WHEREAS the Petitioner above named through its Advocate SRI SRINIVASA MURTHY CHEEDELLA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue any appropriate writ, order or direction one more particularly one in the nature of Writ of Mandamus declaring the action of the 2 and 3 for not taking any action on the representation dated 27/01/2020, 18/08/2020 and 18/11/2020 submitted by the petitioner against the illegal construction made by third parties without any permission in respect of land admeasuring Ac.37-15 gts in Sy Nos.104/1, 105/1, 106/1, 107/1, 108/1, 109/1 and 113/1 situated at Puppalguda Village, Gandipet Mandal, Ranga Reddy District and as illegal, arbitrary and unconstitutional apart from the provisions of the Municipalities Act, 1955 and the Hyderabad Metropolitan Development Authority Act, 2008 and consequently direct the respondents to forth with consider the representation dated 27/01/2020, 18/08/2020 and 18/11/2020 submitted by the petitioner and to take action in respect of land admeasuring Ac.37-15 gts in Sy Nos.104/1, 105/1, 106/1, 107/1, 108/1, 109/1 and 113/1 situated at Puppalguda Village, Gandipet Mandal, Ranga Reddy District;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri SRINIVASA MURTHY CHEEDELLA Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
