WHEREAS the Petitioner above named through his Advocate SRI VADEENDRA JOSHI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ of Mandamus, or any other appropriate writ, order or direction, declaring the inaction of the Respondent No. 3 in failing to consider and dispose of the Petitioner's representations dated 06.05.2026, 02.06.2026 and 12.06.2026 as illegal, arbitrary and violative of Article 14 of the Constitution of India and consequentially, directing Respondents 2 and 3 to consider and dispose of the said representations, by a reasoned order and after affording the Petitioner an opportunity of hearing, within 2 weeks and such time as this Honorable Court may fix, including by ordering an inquiry under Section 51 of the Act into the

conflicted appointment of the Internal Auditor, the alleged financial irregularities, and the alleged fabrication of the minutes dated 28.03.2026, if and to the extent warranted.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. VADEENDRA JOSHI Advocate for the Petitioner, directed issue of notice to the Respondent No.5, herein to show cause as to why this WRIT PETITION should not be admitted.
