WHEREAS the Appellant above named through his Advocate Sri V Rohith presented this Appeal under Section 19 of the Family Courts Act R/w Order 43 Rule 1 of CPC Act against being aggrieved by the order passed by the learned Judge, Principal Family Court, at Secunderabad in IA No. 1028 of 2025 in FCOP No. 716 of 2023 dated 13-5-2026 dismissing the application which was filed under Order 9 Rule 13 CPC R/w 151 CPC for setting aside the exparte decree dated. 13-6-2024 passed against her granting divorce in FCOP No. 716 of 2023 dated 13-6-2024.

In the light of the same, issue notice to respondent.

Personal notice is permitted.

Learned counsel for the petitioner is also permitted to serve notice on the counsel appearing for respondent herein in FCOP No.716 of 2023 pending on the file of the Judge, Principal Family Court at Secunderabad.
