ORDER:

Heard learned counsel for the petitioner and Sri P.Radhive Reddy, learned Special Government Pleader representing the Office of the learned Advocate General.

Both the counsel submit that in similar circumstances this Court was pleased to grant interim stay on 18.10.2021 in WP.No.14670 of 2021, in respect of the lands sought to be acquired for proposed Green Pharma City and the petition subject lands are also located therein.

Having regard to the said fact, and for the reasons alike, there shall be interim stay as prayed for till 15.11.2021.
