Petition under Section 151 of CPC, praying that in the circumstances stated in the grounds filed in support of the CRIMINAL REVISION CASE, the High Court may be to stay all further proceedings pursuant to the Order dated 25.03.2026 in Crl.M.P.No.533 of 2019 in M.C. No.62 of 2019 pending on the file of Additional Family Judge, Medchal-Malkajgiri District at Kukatpally, including recovery of arrears of maintenance, pending disposal of CRLRC No. 678 of 2026, on the file of the High Court.

The Court made the following

ORDER:

This Interlocutory Application is filed by the Revision Petitioner/Respondent to stay all further proceedings pursuant to the order dated 25.03.2026 in Crl.M.P.No.533 of 2019 in M.C.No.62 of 2019 including recovery of arrears of maintenance in interest of justice pending on the file of Court of Additional Family Judge, Medchal-Malkajgiri District, Kukatpally.

Learned counsel for the petitioners submitted that though the documents were filed from the year 2021 regarding the income of the petitioner herein, the trial Court allowed the petition from the year 2026 which is in arrears on record. The order requires to be reduced. As such, requested the Court to stay the same till the disposal of the revision petition.

Learned respondents/petitioners submissions made by the learned counsel for the revision petitioner/respondent, stating that even after the amount was awarded, no such amount was paid.

Considering the submissions made by the learned counsel for the petitioner, there shall be stay of all further proceedings in pursuant to the order dated 25.03.2026 passed in Crl.M.P.No.533 of 2019 in M.C.No.62 of 2019, on the file of Court of Additional Family Judge, Medhal-Malkajgiri District Kukatpally, on condition to deposit an amount of Rs. 10,00,000/- (Rupees Ten Lakhs Only) within one month from the date of copy of this order, failing which stay may be vacated automatically.
