The Court made the following ORDER:

This Court, while disposing of the Contempt Case on 10-03-2023, has taken into consideration the submissions made in the counter affidavit filed by the respondents. However, liberty was granted to the petitioner to file fresh application, if any cause survives, in accordance with law.

I.A.No.1 of 2023 is filed seeking restoration of C.C.No.1587 of 2019 on the ground that, even after granting interim orders by this Court, the respondents have granted building permission in the survey numbers mentioned in W.P.No. 16424 of 2018 and this fact was not brought to the notice of this Court.

Since this application is filed on the ground that factual aspect has not been brought to the notice of this Court, this Court deems it appropriate to recall the order passed by this Court on 10-03-2023 in C.C.No.1587 of 2019.

Accordingly, the order, dated 10-03-2023 passed in C.C.No.1587 of 2019 is recalled.

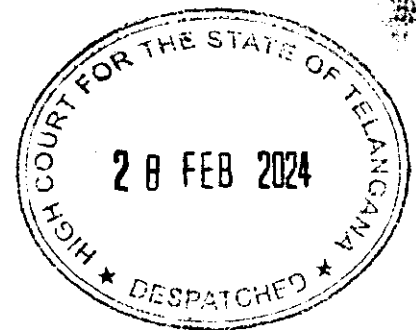
