entering missing extent of land in Bhu Bharathi Portal by issuing Pattadar passbook and Title Deed in favour of petitioner.

ORDER:

Heard M/s.S.Maruti Rao, learned counsel for the petitioner and Ms.Dara Haritha Kiran, learned Assistant Government Pleader representing learned Government Pleader for Revenue for respondent Nos.1 to 4.

2. The petitioner is aggrieved by the action of the respondents in not considering the online Dharani Application Transaction ID:313108000012418, dated 11.07.2022 for correction of entries, omissions in respect of land in survey Nos.411/Aa1, 411/Aa2 situated at Arutla village, Kandi Mandal, Sanga Reddy District (for short 'the subject property').

3. Learned counsel for the petitioner submits that since no action has been initiated by the respondents with regard to the online Dharani

application, the petitioner has made another representation on 04.07.2025. In spite of the same, no action has been initiated till date. Hence, the present writ petition is filed.

4. Learned Assistant Government Pleader submits that the application pertains to the year 2022, and the said application was given for the purpose of correction of entries and omissions in respect of the subject property. In view of the matter, if the petitioner makes any fresh application, the same would be considered along with pending application dt.11.07.2022 and representation dt.04.07.2025.

5. Recording the same, without going into the merits, the writ petitioner is disposed of granting an opportunity to the petitioner to file a fresh online Dharani application within a period of four (4) weeks from the date of receipt of the copy of this order. Upon receipt of such application from the petitioner, the respondent Nos.4 and 5 shall consider the same along with the application dated 11.07.2022 and representation dated 04.07.2025 and pass appropriate orders within a period of six (6) weeks thereafter.

Miscellaneous petitions, if any, pending in this writ petition shall stand closed. No costs.
