Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ, order or direction more particularly one in the nature of Writ of Mandamus by declare the action of Respondents in interfering with the right of enjoyment of the Petitioner over the land admeasuring Ac. 14.86 cents comprised in Sy.Nos.25/1, 29/3, 24/1, 26/2A of Morrapudi village covered by Registered Sale Deed bearing Document No. 2108/2001 dated 26.06.2001 which is under provisional attachment as per G.O.Ms.No. 212 (Annexure - IV) Home (General B) Department dated 22.09.2001 as illegal, arbitrary in violation of Article 300-A of Constitution and in violation of provisions of Protection of Depositors of Financial Establishments Act, 1999 and consequently direct Respondents not to interfere with the right of enjoyment of the Petitioner over the land admeasuring Ac. 14.86 cents comprised in Sy.Nos.25/1, 29/3, 24/1, 26/2A of Morrapudi village covered by Registered Sale Deed bearing Document No. 2108/2001 dated 26.06.2001.
