The Court made the following

ORDER

Learned counsel appearing for the appellant/Insurance Company has handed up a Calculation Memo on 75% of the compensation amount, along with interest and costs amounting to Rs.59,86,202/-, out of which Rs.25,000/- was already deposited before the learned Tribunal.

There shall be stay of the operation of the impugned order and the decree dated 28.07.2025 passed by the learned Chairman, Motor Accidents Claims Tribunal-cum-XIV Additional Chief Judge, City Civil Courts, Hyderabad, in M.V.O.P.No.1625 of 2018, subject to the appellant depositing Rs.59,61,202/-, within a period of four weeks from tomorrow i.e., 15.07.2026.

The respondent No.1/claimant shall be at liberty to withdraw the amount deposited by the appellant in the same proportion as was directed by the Tribunal, subject to TDS.
