No. 42 of 2021 on the file of the VII Additional District and Sessions Judge, Karimnagar, and upon such calling for of records, consequently quash the said Award, the same having been obtained by collusion and fraud played by Respondent Nos. 3 and 4 herein.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to suspend the operation of the Award dated 12.03.2022 passed by the 2nd Respondent in L.A.C. No. 79 of 2022 in O.S. No. 42 of 2021 on the file of the VII Additional District and Sessions Judge, Karimnagar,, pending disposal of WP No 19866 of 2026, on the file of the High Court.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to stay the proceedings in E. P. ORDER

We have heard learned counsel appearing for the respondent Nos.3 and 4 (landlords of the schedule property) and learned Senior Counsel appearing for the petitioner who has challenged the Lok Adalath Award dated 12.03.2022, in which the petitioner was not a party.

With regard to the prayer for interim stay of the Execution Petition (E.P.No.30 of 2024) arising out of the Award dated 12.03.2022 filed by the petitioner, we do not wish to consider the prayer for interim stay of the Execution Petition filed by the respondent No.3 in E.P.No.30 of 2024 in view of the submissions made by learned counsel appearing for the respondent Nos.3 and 4 that the said respondents have not taken any steps in the Execution Proceedings till date.

List this matter on 19.08.2026 for learned Senior Counsel and learned counsel appearing for the parties to file their respective Notes.
